Or

- c. One similar completed work costing not less than the amount equal to 90% of the cost limit in respective Class.
- 4. Enclosures: Applicants must enclose duly certified Xerox copies of all relevant information in support of their statements/facts.
- 5. If the application is made by a partnership firm, a certified copy of the partnership

deed, current address of the firm and the full name and current addresses of all the partners of the firms shall be furnished / accompany the application.

If the application is made by a limited company, it shall be signed by a duly authorized person holding the power of Attorney for signing the application in which case certified copies of power of attorney and the certification of incorporation, Memorandum and Articles of Association shall accompany the application.
