Now we have left with only one bidder who qualify the Technical bid Ms Bharat IT Services.

As per Standard Operating Procedure for Procuement of Goods and Services of OICL dated 13-02-2024, page no 32 "Dealing with Single bids" if bid have been extended appropriately and even after extension of time only 1 bid is recived the same shall be opnened by giving Justififed reasons.

Now as we have given 3 extension in the validity of tender on GEM to improve participation from vendors, we have rececived only 3 bids, out which two bids didn't qualify in eligibility cum Technical evaluation and as our current tender is going to expire on 31-03-2024, it is requested to open the commercial bid for Ms Bharat IT Services. Further if the price for Table 1 of commercial bid is found to increase more than 5 % from the last tender, we can call in Ms Bharat IT Services for negotiations.

#### CHAPTER - 8

### AWARD OF CONTRACT AND REJECTION OF BIDS

#### AWARD OF CONTRACT

Contract should be awarded to the lowest evaluated bidder whose bid has been found to be responsive and who is eligible and qualified to perform the contract satisfactorily as per the terms and conditions incorporated in the corresponding bidding document. The Successful Bidder should be instructed to furnish the required Performance Security Deposit within a specified period. The name of the successful bidder awarded the contract should be mentioned at the company website. Before the award of contract, it must be declared by the competent authority that the rates quoted are reasonable.

In case the rates are not reasonable, the competent authority shall not award the Bid and shall go for the re-Bid. The terms of the contract shall be largely based on the tender documents without any material deviation. List of documents which will be part of contract and other formats/annexures shall be

#### REJECTION OF BIDS

All Bids shall be rejected under the following circumstance/s

- a. effective competition is lacking (e.g. only single bid is received).
- b. all Bids and Proposals are not substantially responsive to the requirement of the Procurement
- c. the Bids'/Proposals' prices are substantially higher that the updated cost estimate or available budget; or
- d. none of the technical Proposals meets the minimum technical qualifying score.

#### DEALING WITH SINGLE BIDS


In case only 1 bid is received after the stipulated time, the same shall not be opened at first instance and the time for submission of the Bid shall be extended appropriately (minimum 07 days). It shall also be seen at the time of extension that the terms of the Bid are not restrictive. If the terms are found to be restrictive. the same shall be relaxed appropriately. Even after extension of time with relaxed conditions, only 1 bid is received the same shall be opened by giving justified reasons.

The following conditions shall be fulfilled for opening of single bids.

- The Bid was satisfactorily advertised, and sufficient time was given for submission of bids.
- · The qualification criteria were not unduly restrictive; and
- · Prices (as per the price discovery done by the user Dept. through formal/informal enquiries) are reasonable in comparison to market values.
