- The Induction training will be held at OSTC, Faridabad at a later date which will be informed subsequently.
- It may be noted that training is mandatory and confirmation is subject to successful completion of training.
- The important documents to be submitted at the time of reporting at the Regional Office are as per **Annexure** "B".
- Specimen copy of Service Agreement cum Guarantee Bond and Undertaking from Surety are as per **Annexure** "C".

The candidate should ensure that he/she fulfils the eligibility and other norms mentioned in the recruitment advertisement and that the particulars furnished by him/her are correct in all aspects.
