The first round of Direct Recruitment of Administrative Officer (Scale-I) has been completed and based on the data of unfilled vacancies we have received a list of qualified candidates in the balance merit list from National Insurance Company who have now been provisionally selected for appointment by the Competent Authority.


The list of candidates is enclosed. We would request the candidates to strictly adhere to the following instructions.

- The provisionally selected candidates as per enclosed list are being advised to approach the respective Regional Office under which their names appear in the enclosed list for Medical Examination.
- The candidates should appear before the Medical Board as advised by our Regional Office concerned immediately and latest by **9th January 2015**. In case a candidate does not report for Medical examination by **9th January 2015** -, it will be construed that the candidate is not willing to join the Company.
- The Medical Examination for the first time will be done free of cost. If a candidate incurs any expenditure towards it, the same will be reimbursed by the Company against submission of bills.
- If the candidate is required to undergo Medical Examination again due to unsatisfactory report of the first Medical Examination, the charges, if any, will be borne by the candidate only.
- The traveling expense, if any, in connection with the above, either for the Medical Examination for the first time or for subsequent Medical Examination, will be borne entirely by the candidate and no reimbursement will be made for the same.
- In case the candidate is in employment, he/she will have to submit a clear Relieving/Discharge letter from his/her employer in original on the day of reporting for joining the Company's office. Please note that under no circumstances, he/she will be allowed to join the Company where the Relieving/Discharge letter is not produced. **This requirement will come after issuance of Appointment Letter if any.**
- Candidates will have to bring original testimonials along with attested photocopies (in duplicate) and four recent passport size photographs at the time of reporting for pre-employment medical examination. Original caste certificate along with attested photocopies is also to be brought in case of SC/ST/OBC candidates.
- The persons with Disability will have to produce Disability Certificate, issued by the Appropriate Authorities, at the time of reporting for pre-employment medical examination.
- Ex servicemen are required to submit appropriate certificates viz copy of ex-serviceman service book, original release order, etc at the time of reporting for pre-employment medical examination. Originals of copies shall also be produced for verification.
- **The advices for reporting to the Regional Office is only for facilitating Medical Examination and must not be taken as an indication of appointment or final posting.**

Kindly note that mere appearance of names in the selection list does not entail any candidate for appointment in the Company. The issuance of Provisional Appointment is subject to satisfactory reports of Medical Examination, Caste Certificates, testimonials and any other documents(s) as may be required. In case, it is found, at any stage even after appointment in the Company, that the candidate does not fulfill any of the criteria and/or the candidate has furnished any incorrect/incomplete information or has suppressed any material facts(s), his/her candidature will be cancelled. The decision of the Company in this regard shall be final and no correspondence will be entertained with the candidates.

It may be noted that this is the final offer of recruitment after which no extensions will be granted as we will be commencing the next Recruitment Exercise.
