2	Whether Registration with GST is compulsory?	GST registration is compulsory for the bidder
3	Whether it is mandatory to submit certificate from Chartered Accountant about the number of employees available with the bidder OR does it suffice if the proof of remittance of PF / ESI showing the number of employees (ECR form) with the bidder is submitted?	If the proof of remittance of PF / ESI (showing the existing number of employees of the bidder) is submitted, it will be sufficient.
4	In page 39 of Technical bid in point no.13, the details of bid Security Deposit are asked. Whether it is mandatory to submit these details?	The Security deposit will be paid by the successful bidder who is selected by OICL Hence, these details are not necessary while submitting the technical bid.
5	Whether the proof of remittance of PF, ESI and GST can be submitted by the bidder to OICL at a later date for claiming reimbursement?	The proof of remittance of PF / ESI and GST should be submitted by the bidder along with the invoice for reimbursement of wages paid to the housekeeping workers and driver.
6	What will be the basis for deciding the successful bidder if more than one bidder quotes the same rate in the Financial bid? Will the existing contractor get any preference over others in such a situation?	The committee formed for the selection of the bidder will decide the matter. If the same rates are quoted by more than one bidder, the decision of the DGM, OICL will be final in this matter.
