During the pre bid meeting held at R. O.Visakhapatnam the following queries were raised by the bidders and same were answered.

S.No.	Query raised	Reply given
1	A Query was raised in regard to point number 6 of eligibility criteria of paid up capital of Rs.10 Crore.	This requirement of paid capital of 10 crore applies to the Insurance company/Public sector Banks and others institutions mentioned in the point number 6 of Eligibility criteria to whom the bidder is providing service. The amount of Rs.50 lac mentioned in check list for documents in point number 7 should be replaced with Rs. 10 crore and not Rs.50 lac.
2	Whether a separate letter from Registering authority is necessary certifying exemption from EMD or Certificate of Registration as MSE is enough	A valid Certified copy of Certificate of Registration as MSE issued by appropriate Registration Authority and valid written proof certifying exemption from payment of Earnest Money Deposit(EMD) to such MSE are required.
3	Whether it is mandatory to submit certificate from Chartered accountant about the number of employees available with bidder or is it sufficient if the proof of remittance of PF/ESI showing the number of employees with the bidder is submitted	If the proof of remittance of PF/ESI/ showing the existing number of employees of bidder)is submitted, it will be sufficient.
4	Whether Minimum Wages of State/ Central Govt. and revised wages for every six months is applicable if it is State Govt. minimum wages,whether it is Unskilled or Safai Karmachari. What is trade.	Refer point number 9 instructions for bidders. It was clearly mentioned as Andhra Pradesh State only. Also refer point number 2 of section 4. Safai Karmacharis/unskilled for cleaning, sweeping, dusting, polishing, helping, attending etc. to work in R.O.Visakhapatnam and various offices of its region.

Accordingly the clarifications given above will supplement/replace the respective wordings given in the revised tender document uploaded . The bidders are requested to take into consideration above while submitting the bids.
