1. The Bids should be submitted separately for each car in a closed envelope addressed to Chief Manager, Establishment Deptt., The Oriental Insurance Company Limited, Oriental House, A-25/27, Asaf Ali Road, New Delhi in the prescribed Bid Format enclosed herewith duly superscribed "**TENDER FOR SALE OF CAR NO. DL-12CE-3365 & DL-3CBD-6219**".
2. The interested bidder and employees of the Company can also participate and submit their Bids.
3. The Bid for each car submitted should be accompanied by **Earnest Money Deposit of Rs. 10,000/- by way of Demand Draft Only in favour of "The Oriental Insurance Company Limited"**, in the absence of which the bids will be treated as rejected. Bids/Offeres accompanied by payment of Earnest Money Deposit through cheque will also be treated as rejected.
4. It is informed to all the Bidders that **in addition to payment of Bid Price they have to pay 18% GST on the Net Amount (i.e. Bid/Sale Price minus WDV of car) as per GST rules applicable on sale of second hand car.**

5. If the amount quoted by the Bidder is highest, the Demand Draft submitted along with the Bid will be deposited in Company's Bank Account and the Bider will have to take delivery of the car on deposition of the Balance Bid Amount (**i.e. final bid amount inclusive of GST calculated as per Clause 4 above minus EMD deposit**) and the requisite documents for transfer of car in his/her name. In case the bidder fails to deposit the Balance Bid Amount within ten days of the notice/award in this regard, the "Earnest Money Deposit (EMD)" deposited by the bidder /employee with the Company along with the Bid will be forfeited and will not be refunded. In such an event, the car in question will be disposed off as per the decision of Competent Authority of the Company.
6. The delivery of car will be given to the highest Bidder only on deposition of **Final Bid Amount (inclusive of 18% GST on Net Value as per Clause No. 4 above)** and after submission and deposition of all requisite papers including address proof and identity proof with the RTO for transfer of car in the name of highest bidder only. The highest bidder will have to submit all the papers required for submission to RTO for transfer of car in his/her/their name within thirty days from the date of offer.
7. The Bidder is required to submit the following Identity Proof and residential proof documents along with the Tender for Sale of Car: -
 1. Copy of Aadhaar Card of the Bidder.
 2. Copy of Residential Proof of the Bidder.
 3. Certificate of Registration of Firm, in case the Bidder is a registered firm.
 4. PAN Number. & GST NO.
 5. Identity Proof i.e. Voter Card, Passport etc.
 6. Any other documents required by RTO for transfer of car.
8. All formalities regarding transfer of vehicle in the name of highest bidder will be completed by the successful bidder within one month and the delivery of the vehicle will be given to the Bidder only after deposition of documents with RTO for transfer of car.
9. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his/her/their name at his/her/their own cost. The Company will not be responsible for any lapse on his/her/their part in this regard.
10. The vehicles will be sold on "AS IS WHERE IS BASIS" and no guarantee for its worthiness or quality be given by the Company.
11. The employees of the Company who desire to participate in this tender process are advised to take proper permission from their respective Head of the Department before leaving the office for inspection of the Staff Car.
12. All Bidders participating in Sale of Old Car are hereby informed that they have to bear all expenses, fees and road tax/registration charges payable to RTO for transfer of car in addition to the price quoted by them in their Financial Bid. The company will only sign the documents for transfer of car in the name of the successful bidder.

13. The Bidder interested in buying the above-noted Staff Car are advised in their own interest to submit Tender only after inspection of the Car. They are also advised to carefully read the terms and conditions of Tender for Sale of Car as they are required to complete all the formalities including formalities pertaining to transfer of car in the name of the Successful Bidder only and RTO fees, road tax and registration expenses, if any, required for transfer of vehicle in his/her/their name, are to be borne by the successful bidder.
