**NOTICE IN CONNECTION WITH TPA ALLOCATION / RE-ALLOCATION**

The Oriental Insurance Company Limited carried out an exercise for fresh empanelment of Third Party Administrators (Health) as well as their Allocation / Re-allocation for Retail line of business.

The objective of the exercise was to broad base the list by inviting applications from licensed TPAs, create healthy competition, to have equitable business allocation amongst the final list of TPAs on the basis of their business performance / SLA parameters, help in effective claims management and also provide more choices to the Policyholders / ROs.

The exercise in previous years was being conducted by the HO department but to have a better transparency and objectivity in selection as well as allocation / re-allocation of TPAs a Committee of General Managers was constituted for the same to achieve the broader corporate goals.

In line with the existing practice the committee allocated existing and fresh TPAs to the Regional Offices as detailed below :-
