- **A.** The intending bidder should have his own registered firms at **Mumbai** with GST Registration No. and be financially sound.
- **B.** Latest Sales Tax Certificates issued by Competent Authority must be attached.
- **C.** Bidders are advised to study the terms and conditions carefully. Submission of Quotations shall be deemed to have been done after careful study and examinations of the Terms & Conditions with full understanding of its implications.
- **D.** The rate of each item should be quoted in the manner as indicated below -

- b) Both the Technical Bid cover and Commercial Bid Cover, prepared as above, are to be kept in a single sealed cover superscribed with "Tender for Laptop".
- c) The cover thus prepared should also indicate clearly the name, address and contact details of the Bidder, to enable the Bid to be returned unopened in case it is declared "Late".
- (ix) The successful bidder will have to supply the items within the period specified in the purchase order without fail. No extension of time without any valid reason whatsoever will be granted.
- (x) Supply of items with inferior quality or other than quoted or different from required specification, poor workmanship or failure to supply in time, may results in cancellation of the purchase order at the cost of the concerned vendors/firms.
