Vide Note Ref. No. ITD/HO/2018/N/366 dated 22.06.2018 (Copy attached as **Annexure-A**), Competent Authority approved Procurement of IT Security Related Tools and Services through Open Tender.

Accordingly, Tender Ref. No OICL/HO/ITD/SOC/2018/01 dated 13.07.2018 was floated for Selection of Vendor for Supply, Installation, Implementation, Integration, Maintenance and Support of Security System. Further, vide Note Ref. No. ITD/HO/2018/N/581 Dated 19.09.2018 (copy attached as **Annexure-B**), Competent Authority approved the revised schedule of events for above tender.

In response to the above RFP, following two bidders submitted their bids online through e-Procurement Technologies Limited portal within scheduled date and time of submission i.e. 25.09.2018 till 3:15 PM.

1. M/s Sify Technologies Limited
2. M/s Tata Communication Limited

The pre-qualification bids were opened on 25.09.2018 at 3:30 PM in the presence of Technical Committee and the representative of Bidders (Copy of attendance sheet attached as **Annexure-C**).

While scrutinizing the Pre-Qualification bids as per the Eligibility criteria defined on page no. 16, 17 & 18 of the RFP and the list of Eligibility Bid Documents to be submitted mentioned on page no.68 & 69 of the RFP, few gaps were observed (Bidder wise list of gaps attached as **Annexure-D**). Accordingly, clarifications were sought and respective bidders submitted the required documents (Bidder wise Clarifications attached as **Annexure-E**).

Vide email dated 01.11.2018 (Copy of Email attached as **Annexure - F**), our IT Consultant M/s KPMG has recommended in the Report that both the above bidders are meeting the Eligibility Criteria and Technical bids of these bidders may be opened.

The compliance checklist of documents as per Eligibility Criteria of RFP is attached as **Annexure-G**.

The Department observed that all the above two Bidders are complying with the Eligibility Criteria required as mentioned in RFP.


