We would like to inform you that the Company is a 'high value debt listed entities' as it has listed non-convertible debt securities having an outstanding value of Rupees Seven Hundred Fifty Crores. Hence, the regulations 15 to regulation 27 of the SEBI LODR 2015 are applicable to our Company. Further, pursuant to Second Proviso to Regulation 15(1A) of SEBI (LODR) Regulations, 2015, the compliance of regulations 15 to regulation 27 are applicable on the company on 'comply or explain' basis until March 31, 2023 and on a mandatory basis thereafter.

Further, as the Company is in the business of Insurance, it is governed by the IRDA Act and rules and regulations prescribed thereunder also. We are in the process of examining newly applicable provisions of the SEBI LODR under Regulations 15 to 27 in the backdrop of the applicable IRDA regulations as the IRDA regulations may have an overarching impact vis a vis SEBI LODR regulations. Accordingly, our Company shall not be submitting the Annual Secretarial Compliance Report under Regulation 24A of the SEBI (LODR) Regulations, 2015 for the year 2021-22.
