If the amount quoted by the Bidder is highest, the Demand Draft submitted along with the Bid will be deposited in Company's Bank Account and the Bidder will have to take delivery of the car on deposition of the Balance Bid Amount (ie. Final Bid amount inclusive of GST calculated as per Clause 4 above minus EMD Deposit).
