The allocation of existing and fresh TPAs will be effective from 1st April, 2020.

As per Insurance Regulatory and Development Authority of India (Third Party Administrators – Health Services) (Amendment) Regulations, 2019 dated 03-12-2019 the policyholder can choose a TPA of their choice from amongst the TPAs engaged by the insurer, where services of TPAs are engaged by the insurer. Accordingly, TPAs allotted to Regional Offices will now be available for services to all the Operating Offices coming under the jurisdiction of respective Regional Office.

TPA Allocation / Reallocation shall be applicable for new policies/renewals issued after effective date i.e. 1st April, 2020 and selection/ change of TPA will be done only after obtaining written and signed confirmation by the proposer/Insured not by an agent / intermediary.

If a same TPA is reallocated to the office under new guidelines effective from 1st April, 2020 renewals to be done under same TPA until and unless insured opts for a change and give in writing for change of TPA. Where allocation of existing TPA is changed due to any reason then all allotted TPAs to that Regional Office will be offered as a choice to the policyholders.

Final allocation / reallocation of TPAs is applicable for new policies and for renewals w.e.f 1st April, 2020. All policies prior to that will run as it is till their expiry.

No TPA shall be changed Mid-term in any policy.

All operational offices should display the list of all TPAs allocated to them at prominent place in the office, out of which the customer can choose the TPA themselves.

A mail with regard to revised final allocation of existing and fresh TPAs is also being sent to Regional Incharges, Regional Manager (Health) and concerned TPAs.

The allocation of existing and fresh TPAs will be implemented in our IT system w.e.f 1st April, 2020.
